Mark schemes are prepared by the Lead Assessment Writer and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation events which all associates participate in and is the scheme which was used by them in this examination. The standardisation process ensures that the mark scheme covers the students' responses to questions and that every associate understands and applies it in the same correct way. As preparation for standardisation each associate analyses a number of students' scripts. Alternative answers not already covered by the mark scheme are discussed and legislated for. If, after the standardisation process, associates encounter unusual answers which have not been raised they are required to refer these to the Lead Assessment Writer.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of students' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

## Paper 2 Mark Scheme

Welcome to this mark scheme which is designed to help you deliver fair and accurate assessment. Please read all sections carefully and ensure that you follow the requirements that they contain.

### The significance of open book

Examiners must understand that in marking an open book exam there are examining implications. Candidates have their texts in front of them, and they are expected to use them to focus on specific passages for detailed discussion. They will not have had to memorise quotations, so when quotations are used they should be accurate. Because candidates have their texts in the examination room, examiners need to be alert to possible malpractice. The texts should not be annotated, but if examiners suspect that they have been or that notes from texts have been copied, they must alert the malpractice team.

There are specific issues for AO2 – how meanings are shaped in texts. There is, with open book, the expectation that candidates can use the text they have in front of them to make specific and detailed reference to structural and organisational issues.

### Arriving at Marks

1. All questions are framed to address all the Assessment Objectives (AOs). Weightings are given above the generic mark scheme. Answers are marked holistically but, when deciding upon a mark in a band, examiners should bear in mind the relative weightings of the assessment objectives (see page 6) and be careful not to over/under credit a particular skill. This will be exemplified and reinforced as part of examiner training and standardisation. Examiners need to read the whole answer taking into account its strengths and weaknesses and then place it in the appropriate band.
2. Examiners should avoid making early snap judgements before the whole answer has been read. Some candidates begin tentatively but go on to make relevant points.
3. Examiners should be prepared to use the full mark range and not 'bunch' scripts in the middle for safety. Top band marks are attainable if candidates could not be expected to do more in the time and under the conditions in which they are working.
4. Examiners should mark positively. Although the mark scheme provides some indicators for what candidates are likely to write about, examiners should be willing to reward what is actually there – **provided of course, that it is relevant to the question being asked.**
5. Examiners should remember that there is no one right answer. Candidates' views which are relevant, well-argued and supported by appropriate textual evidence must receive credit whether the examiner agrees with the views or not. It is important to try to remain flexible if a candidate introduces unusual or unorthodox ideas.
6. Examiners should remember that length and quality are not synonymous. Some brief answers may be relevant and concise. Equally, long answers may be diffuse and repetitive.
7. If answers are short or incomplete, examiners can only reward what is there and assess accordingly. Some further credit may be given to answers finished in note form.

**Using the Mark Bands**

8. When placing answers in mark bands, examiners need to look closely at the descriptors and the detailed generic mark bands on page 8. The key words for the bands are important and are printed below.

MARK BAND DESCRIPTORS	
Band 5	perceptive/assured
Band 4	coherent/thorough
Band 3	straightforward/relevant
Band 2	simple/generalised
Band 1	largely irrelevant, largely misunderstood, largely inaccurate

9. Answers placed at the top of the band will securely address the descriptors; answers at the lower end of the band will securely address the descriptors below and begin to show the qualities of the band into which you are placing them. Careful judgements need to be made about marks in the middle of the range; here it is likely that the key descriptors will be more intermittent but still clearly evident.
10. There will be occasions when an answer addresses descriptors in different bands; in such cases, the 'best-fit' model applies. Here examiners will need to exercise a different kind of judgement, looking to see where the answer can be most fairly and appropriately placed in terms of its quality against the descriptors.
11. Examiners must remember that the mark bands are not equivalent to grades: grades are decided by the awarding committee at the end of each session.

**Advice about marking specific sections**

12. Examiners need to bear in mind the following key points when marking extract based questions:
- has the candidate engaged in a relevant debate?
  - does the candidate have an overview of the extract(s)?
  - has the candidate written about authorial method(s)?
  - has the candidate seen the significance of the extract in relation to the central historicist literary concept?
  - has the candidate quoted from the extract to support ideas?
  - the candidate's AO1 competence.

In the case of a significant omission to an answer, ie an omission which prevents the candidate from fully answering the question, then the examiner should not give a mark higher than Band 3. Such an answer is likely to be given a mark lower than Band 3.

13. Examiners need to bear in mind the following key points when marking questions connecting two texts:
- has the candidate focused on the central historicist literary concept set up in the question and referred to two texts?
  - has the candidate engaged in a relevant debate or constructed a relevant argument around the two texts?
  - has the candidate considered the writers' authorial methods in the two texts?
  - has the candidate adhered to the rubric ?
  - has the candidate given substantial coverage of two texts?
  - the candidate's AO1 competence.

In the case of a significant omission to an answer, ie an omission which prevents the candidate from fully answering the question, then the examiner should not give a mark higher than Band 3. Such an answer is likely to be given a mark lower than Band 3.

### **Annotation**

14. Examiners should remember that annotation is directed solely to senior examiners.
17. In addition to giving a mark, examiners should write a brief summative comment indicating how the mark has been arrived at. These comments are likely to mirror the appropriate mark band descriptors but comments must not be mechanical. Examiners need to describe candidate performance.
18. Please remember that scripts can go back to candidates, so although your audience is a senior examiner, you must express your views temperately.
17. The following symbols can be used when marking scripts:
- tick for a good point, idea, reference etc
  - REP for repetition
  - IR for irrelevance
  - ? for when meaning is not clear
  - SEEN to acknowledge blank pages and plans/footnotes made by students.

Please do not use your own private systems, as these will mean nothing to senior examiners. If in doubt about what to use, simply write clear comments.

### **The Assessment Objectives and their significance**

19. All questions are framed to test AOs 2, 3, 4 and 5, so if candidates answer the question, then they will be addressing the AOs. In marking questions, however, examiners must also take account of AO1, which tests more than technical accuracy.

The AOs are as follows:

**AO1** Articulate informed, personal and creative responses to literary texts, using associated concepts and terminology, and coherent, accurate written expression. (28%)

- AO2** Analyse ways in which meanings are shaped in literary texts. (24%)
- AO3** Demonstrate understanding of the significance and influence of the contexts in which literary texts are written and received. (24%)
- AO4** Explore connections across literary texts. (12%)
- AO5** Explore literary texts informed by different interpretations. (12%)

**Rubric Infringements**

If there has been an infringement, the whole answer needs to be read and judged on its quality. A mark should then be given based on the best relevant part of the response. The mark given will not be beyond Band 3.

## Mark Scheme

It is important to remember that these students are 16 to 17 years old so we are judging their skills at Key Stage 5.

**Section A: Unseen Prose**

**Question 01**

**0 1** Examine the view that Tóibín presents Tony as a selfish lover in this extract.

Make close reference to the writer's methods in your response.

- quality of argument
- organisation of ideas
- use of appropriate concepts and terminology
- relevance to task

**AO2** Analyse ways in which meanings are shaped in literary texts

Students might consider:

- relevant aspects of prose narrative, for example the use of third person narrative to adopt Eilis' perspective
- the way in which the extract reflects Eilis' increasingly anxious thoughts through the use of adverbs and conjunctions at the start of sentences such as 'maybe', 'but', 'and'
- how change of perspective through the paragraphs makes simple judgement problematic
- the later focus on the act of seeing as a way of presenting Tony as a more complex character
- etc.

**AO3** Demonstrate understanding of the significance and influence of the contexts in which literary texts are written and received.

In exploring this representation of love, students will consider how far the development of this relationship might reflect the time and society in which it is set. Students might consider:

- the cultural differences that might create difficulties in a relationship between an Irish emigrant and an Italian American
- the context of gender may be considered when students explore the contrasting actions of the two lovers and the way in which they view their relationship
- the mid-20th century context that is reflected in the pattern of the courtship
- etc.

**AO4** Explore connections across literary texts

In exploring this representation of love, students will consider this text through taking into account typical prose representations of love in literature. Students might focus on:

- the importance of narrative point of view in characterisation of pairs of lovers
- doubt and insecurity during courtship
- the differing experiences of male and female lovers
- love across cultural or social divides
- etc.

**AO5** Explore literary texts informed by different interpretations

**Candidates may choose to look at both sides of the debate or just one. It is the quality of the candidate's response that matters.**

Arguments in agreement with the given critical view might consider:

- Tony's physical, emotional forwardness at the start of the extract
- Tony's apparent failure to take Eilis' feelings into account
- Eilis' reactions to Tony's behaviour: her lack of eye contact with Tony etc
- Tony's apparent lack of concern about Eilis as seen in the last paragraph
- an interpretation of 'there was no other side to him'
- etc.

Arguments that counter the given critical view might consider:

- how we only see Tony from Eilis' perspective, and we have detailed access to her thoughts but no access to his
- how it is possible to suggest that in the first paragraph Tony is actually quite caring
- that even Eilis herself sees Tony as vulnerable
- etc.

**Accept any valid interpretations, any valid comments on contexts and any relevant integrated comment on prose methods that are embedded into the argument.**

## Section B: Comparing Prose Texts

### Question 02

**0 2** 'In prose fiction, love always hurts.'

By comparing **two** prose texts, explore the extent to which you agree with this statement.

Students may focus on **relevant** aspects of:

- narrative perspective
- form and genre
- structure
- characterisation
- language, voice, imagery and any other literary devices
- etc.

**AO3** Demonstrate understanding of the significance and influence of the contexts in which literary texts are written and received.

In connecting their two prose set texts, students will consider how representations of love can reflect different social, cultural and historical aspects of the respective different time periods in which the texts were written. Students might focus on:

- the differing personal and social pressures that might influence love in their chosen texts
- relevant issues of class, gender, culture, historical period or text type that influence the presentation of love
- the expectations of genre
- etc.

**AO4** Explore connections across literary texts

In connecting their two prose texts about love, students will address the central issue of literary representations of personal feelings. Students might focus on:

- similarity and/or difference at the level of subject matter
- similarity and/or difference at the level of prose and narrative methods and how writers present their thoughts and opinions about the personal experience of love
- the extent to which each text's representation of love can be seen as typical of the prose genre or its historical period
- etc.

**A05** Explore literary texts informed by different interpretations

**Candidates may choose to look at both sides of the debate or just one. It is the quality of the candidate's response that matters.**

Arguments in agreement with the given critical view might consider:

- the differing forms of hurt presented in their texts and how they might be caused by love
- the differing ways in which love might lead to pain
- that the hurt can refer to characters in the novels or to reader response

Arguments that counter the given critical view might consider:

- how far love can alleviate personal or social pain
- novels that present happy and/or positive relationships
- that hurt is not necessarily the end of the process.

**Accept any valid interpretations, any valid comments on contexts and any relevant integrated comments on narrative methods that are embedded into the argument.**

**Question 03**

**0 3** 'Typically, men are presented as characters who seek to dominate their female partners.'

By comparing **two** prose texts, explore the extent to which you agree with this statement.

- etc.

**AO5** Explore literary texts informed by different interpretations

**Candidates may choose to look at both sides of the debate or just one. It is the quality of the candidate's response that matters.**

Arguments in agreement with the given critical view might consider:

- the ways in which men might be seen to dominate relationships in both courtship and marriage
- different ways in which domination can be presented

Arguments that counter the given critical view might consider:

- the extent to which women often control relationships
- the ways in which writers might present successful relationships as equal

**Accept any valid interpretations, any valid comments on contexts and any relevant integrated comments on narrative methods that are embedded into the argument.**
