6 A sunflower grows 12% taller each week. (Level 6)

Currently the sunflower is 2 m tall.

Chris estimates the height after 5 weeks using the following calculation:

$$12\% \text{ of } 2 \text{ m is } 24 \text{ cm}$$

$$5 \times 24 \text{ cm} = 120 \text{ cm}$$

$$\text{So the plant is } 200 \text{ cm} + 120 \text{ cm} = 320 \text{ cm}$$
